With reference to the above, " No Objection Certificate" from Koramangala Division, B'lore is hereby issued for arranging power supply to the proposed Residential Apartment to an extent of 818kw at, Sy No- 114/1 Gunjur village, Bangalore in S7 sub division.

Power supply to your proposed residential apartment will be arranged with the following arrangements:


### Regular Source:-

- a) It is proposed to replace the existing 11kv OH line 4 ACSR wire by coyote wire to a distance of 03KM by providing 15nos of intermediate poles from point A to B and it is proposed to extend 11kv line by using 3x400sqmm UG cable to a distance of about 0.2Km.
- b) It is proposed to provide one RMU of 2OD + 1VL inside the applicant premises.
- .1) You have to develop the infrastructure including the cost of 11KV lines etc. as mentioned above on Self- execution basis through a Government class-1 electrical contractor by paying necessary supervision charges to BESCOM duly observing BESCOM formalities.
- 2) If any KPTCL/ BESCOM lines are passing through the applicant's premises these shall be shifted at your cost. This NOC does not apply to the premises where EHT lines are passing through the premises for which NOC is to be obtained from he concerned authorities
- 3) If any installation existing, in the said premises the same shall be surrendered by clearing all arrears before taking up infrastructure work in the premises.
- 4) While applying for power supply to the above address, all rules as per KERC Electricity supply and distribution code shall be observed.

- 5) Power supply shall be arranged to the said buildings based on the provisions of regulations of BESCOM is applicable at that time
- 6) This "NOC" is issued only for the purpose of obtaining sanction plan for from BDA/ BBMP/Competent authorities and is not a commitment for power sanction from BESCOM. Power supply will be sanctioned when applied for subject to feasibility at that time.
- 7) The approximate load requirement of the above residential apartment is 818kw.

- 9) For MS Residential building / apartments Solar Heaters should be provided with a capacity of 100 Liters either for individual flat or bulk solar water heater to be provided with suitable capacity which may be calculating 100 liters/ flat.
- 10) As per the above, if there is no sufficient space to provide Solar Water heater block of MS Residential/apartments should be provided with solar water heater of capacity 100 liters/ flat either individual or bulk solar water heater by calculating 100 liters/ flat for total No of flats on the top of the block
- 11) In future, if the requested load exceeds 4000 kVA, the Applicant have to provide prescribed space to establish a 66/11kV MUSS at free of cost to KPTCL.

The existing RRNO7SMIP-55 arrears RS 20161.00 to be paid before availing temporary power supply and the installation is to be surrendered.
